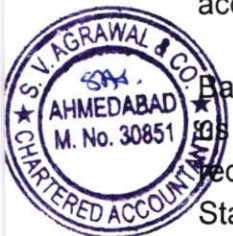

This standard requires that we plan and perform, the statement is responsibilities of the Company's Management and has been approved by the Board of Directors. Our responsibility is to issue a report on these financial statements based on our review

We conducted our review in accordance with the Standard on Review Engagements (SRE) 2410, "Review of Interim Financial Information" Performed by the Independent Auditor of the Entity issued by the Institute of Chartered Accountants of India. This standard requires that we plan and perform the review to obtain moderate assurance as to whether the Statement is free of material misstatement. 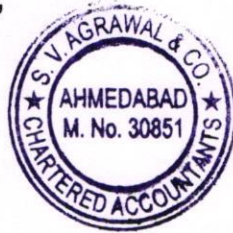
SEBI Circular No. CIR/CFD/FAC/62/2016 dated July 5, 2016, and amendments thereon, including the manner in which it is to be disclosed, or that it contains any material misstatement. During the course of our review, we have observed as under:


1. In the Third Quarter ended on 31.12.2021 the opening stock of Raw material and Finished Goods as on 31/12/2021 have been lying as it is as on 01.10.2021
2. During the Second Quarter ended on 30.09.2021 bill was raised on GWSSB-Kapadwanj Drainage Work for Rs. 1,90,00,000, Credit note for the same amount of bill has been given in Third Quarter.
3. During the Second Quarter ended on 30.09.2021 bill was raised on GWSSB-Khambhat Drainage Work for Rs. 18,00,000 Credit note for the same amount of bill has been given in Third Quarter.
4. GST Return for December, 2021 has not been filed till date, so we are not able to verify the actual sales of the Company.
